L & T Energy Hydrocarbon, (a Division of Larsen & Toubro Limited) an SEZ Unit in L & T Shipbuilding SEZ, Kattupalli, Tiruvallur District who was issued LOA for 'Manufacture, Assembly, Quality Assurance Quality Control, Test, Trial and Load Out of Offshore Platforms And Products piles, Jackets, Topsides and parts thereof, Floating Production and storage units, Semisubmersible, Jack Up, Rig and parts thereof, Manufacture, Assembly, Fabrication Quality Assurance, Quality Control, Test, Trial and Load out of Modules, Pipe Rack, Skids, Heaters and parts thereof for Oil And Gas Sector and Manufacture, Assembly, Fabrication Quality Assurance, Quality Control, Test,


22.9 Request of M/s. JVT Exports Private Limited for setting up a new SEZ Unit in SIPCOT SEZ, Bargur
